PURPOSE:

To set guidelines for the practice of Medical Technologist in Una Konsulta.

LEVEL:

Medical Technologist

POLICY:

- The practice of Medical Technology in Una Konsulta shall abide with professional guidelines as mandated by the code of Medical Technologist ethics in the Philippines.
- 2. All personnel that practice Medical Technology shall update and have possession of their PRC License at all times.
- 3. The following policies are in accordance to Medical Technologist Code of Professional Conduct:
 - 3.1. Medical Technologists shall dedicate their practice to serving the healthcare need of the public.
 - 3.2. Medical Technologist shall protect the confidentiality of all information.
 - 3.3. Medical Technologist shall pratice within the scope of their professional competence.
 - 3.4. Medical Technologist shall work with other healthcare professional to provide effective patient care.
 - 3.5. Medical Technologist shall promote the image and status of their profession by maintain high standards in their professional practice.
 - 3.6. Medical Technologist shall take the responsibility for their professional act.
 - 3.7. Medical Technologist shall endevour to maintain and improve their skills and knowledge and keep current with scientific advances. They shall

uphold academic integrity in all matters of professional certification and continuing education.

- Medical Technologist shall share their knowledge with their colleagues to promote learning.
- 3.9. Medical Technologist shall maintain in accurate, honest record of patient care and activities thereto.
- 3.10. Medical Technologist shall practice safe work procedures at all time to ensure the safety of patients.
- 3.11. Medical Technologist shall acknowledge errors of emission and commission to colleagues, supervisors and patients.

Board of Medical Technology Code of Ethics

As I enter into the practice of Medical Technology, I shall accept the responsibilities inherent to being a professional; I shall uphold the law and shall not engage in illegal work nor cooperate with anyone so engaged; I shall avoid associating or being identified with any enterprise of questionable character;

I shall work and act in a strict spirit of fairness to employer, clients, contractors, employees and in a spirit of personal helpfulness and fraternity toward other members of the profession;

I shall use only honorable means of competition for professional employment or services and shall refrain form unfairly injuring, directly or indirectly, the professional reputation, projects or business of a fellow medical technologist; I shall accept employment from more than one employer only when there in no conflict of interest;

I shall perform professional work in a manner that merits full confidence and trust carried out with absolute reliability, accuracy, fairness and honesty; I shall review the professional work of other medical technologists, when requested, fairly and in confidence whether they are

subordinates or employees, authors of proposals for grants or contracts, authors of technical papers or other publications or involved in litigation;

I shall restrict my praises, criticisms, views and opinions within constructive limits and shall not use the knowledge I know for selfish ends; I shall treat any information I acquired about individuals in the course of my work as strictly confidential, and may be divulged only to authorized persons or entities or with consent of the individual when necessary;

I shall report any infractions of these principles of professional conduct to the authorities responsible of enforcement of applicable laws or regulations, or to the Ethics Committee of the Philippine Association of Medical Technologists as may be appropriate.

To these principles, I hereby subscribe and pledge to conduct myself at all times in a manner befitting the dignity of my profession.
