**PURPOSE:**

To outline the steps involved in receiving blood from the Blood Center for proper documentation.

**SCOPE:**


Applies to all Blood Bank Section Staff of Laboratory Department of Dr. Pablo O. Torre Memorial Hospital (DPOTMH)

**PERSON RESPONSIBLE:**

Medical Technologist (Medical Laboratory Scientist), Nurses, Clerks


**GENERAL GUIDELINES:**

- 1 Impervious gloves and proper protective equipment (PPE) / clothing shall be worn in adherence to Infection Prevention and Control Unit Protocol.
- 2 All blood products shall be considered as biohazard material.
- 3 Endorsed blood unit shall have a Blood Reaction Form from the Blood Center indicating the blood unit was screened and tested negative for the 5 Transfusion Transmissible Infections and includes patient's name, serial number of the blood, expiration date, component and its volume.
- 4 Laboratory Personnel shall check the details of the blood unit if it coincides with the details written on the form.
- 5 An acknowledgment receipt on the blood unit received shall be issued.
- 6 Nurse in charge shall be informed immediately of the details of the blood unit received.

### **PROCEDURE:**

- 1 The Medical Technologist checks. the condition of the blood product endorsed from the Blood Center.
- 2 The Medical Technologist check the following data labeled on the blood unit/s and written in the reaction form/s provided:
  - 2.1 Name of patient
  - 2.2 Age
  - 2.3 Gender
  - 2.4 Serial number
  - 2.5 Expiration date
  - 2.6 Blood component
  - 2.7 Results of the serological tests done for Transfusion Transmissible Infections (TTI)
- 3 The Medical Technologist confirms with the person who endorsed the blood unit if the data written on the form are correct.
- 4 The Medical Technologist then fills up Acknowledgment Receipt Form containing the following information:
  - 4.1 Date and time received
  - 4.2 Name of patient
  - 4.3 Room number
  - 4.4 Blood type
  - 4.5 Blood component
  - 4.6 Serial number
  - 4.7 Expiration date
  - 4.8 Number of units
  - 4.9 Blood center
  - 4.10 Name and signature of patient's representative who endorsed the blood unit


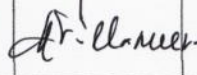


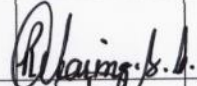

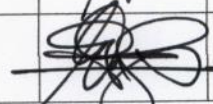

- 4.11 Relationship to the patient of the one who endorsed the unit
- 4.12 Name and signature of the Laboratory Personnel who received the blood unit
- 5 The Medical Technologist issues an acknowledgment receipt to the person who endorsed the blood. A copy must be kept by the Blood Bank for documentation.
- 6 The Medical Technologist labels the blood unit with complete patient's name, date received and indicate PS (Patient Stock)
- 7 The Medical Technologist records received unit/s on the "Blood from outside" logbook provided.
- 8 The Medical Technologist stores the received blood unit/s at Blood Bank refrigerator with a temperature of 2-8 °C.
- 9 The Medical Technologist informs the Nurse-in-charge of the blood unit/s received.
- 10 The Medical Technologist checks condition of the units of blood for hemolysis after 1-4 hours.
