PROCEDURE:

1. Surgical Suites personnel and/or housekeeping aide don proper PPE (eye wear, gloves)
2. Surgical Suites personnel and/or housekeeping aide suctions with disinfectant solution and disconnect suction lines from disposable canister.
3. Surgical Suites personnel and/or housekeeping aide secures all caps to suction ports.
4. Surgical Suites personnel and/or housekeeping aide removes used suction canister from holder.
5. Surgical Suites personnel and/or housekeeping aide places canister(s) (*not more than 8 per yellow plastic bag*) in an upright position into the pass through cart for collection.
6. Surgical Suites personnel and/or housekeeping aide uses disinfectant solution to clean up spills immediately.
