





- 1 The Nurse on duty verifies the Attending Physician's order for the following:
  - 1.1 Proposed schedule for hemodialysis
  - 1.2 Hemodialysis machine set up.
  - 1.3 Ensuring that patient has Hepatitis B<sub>A</sub> <sup>screening test</sup> result
- 2 The Nurse on duty secures an informed consent. (Two (2) copies – one (1) for the patient's chart, one (1) for the Hemodialysis Unit's chart)
  - 2.1 Makes sure that the hemodialysis procedure was clearly explained by the Attending Physician or Resident on duty to the patient and/or his significant other.
  - 2.2 Assesses the mental capacity of the individual involved in consenting for the hemodialysis procedure. Then, have the patient or person in authority sign the consent.
- 3 The Nurse on duty calls the Billing Department and checks if the patient's account is okay for hemodialysis.

- 4 If the patient's account not okay, the Nurse on duty instructs the significant others to settle their account at the Billing Section.
- 5 In emergency and STAT cases, the Nurse on duty informs the Billing personnel that the hemodialysis procedure is STAT.
- 6 The Nurse on duty prepares the schedule.
  - 6.1 Completes the data in the form.
  - 6.2 Indicates in the upper right hand corner the patient's hospital and admission number and if the patient is OK or NOT OK for hemodialysis.
- 7 The Nurse on duty sends the schedule to the Hemodialysis Unit for scheduling and informs the receiving hemodialysis of the set up.
- 8 Water system is available at the ICU rooms making the hemodialysis procedure possible to be done inside the unit. This allows the Nurse on duty to do close monitoring of the patient during the entire duration of the procedure.
- 9 The Nurse on duty makes sure that the laboratory results required, such as the Hepatitis Profile, by the Hemodialysis Unit are available prior starting the procedure. This is for the Nurse on duty to ensure that the machine intended for non-infectious and infectious cases are appropriately selected.
